 1. **THE QUEENS PLATINUM JUBILEE BEACON PROJECT – PAGES 34-37**
 A pack of information I've seen from Buckingham Palace encourages every Council to get involved with 'The Queens Platinum Jubilee Beacon' project. This is to take place around 9pm on 2-June-2022. Three options are described; a Calor-gas burner, a brazier or a bonfire.

 Two suppliers of specially designed, re-useable gas burners have been commissioned, both appear to cost £490 + VAT + gas.
 Instructions have been supplied for making a brazier, which requires blacksmith skills.
 Instructions have been supplied for building a bonfire, which look fraught with danger!
 In our community, the Top of the World in Poulter Park would be the obvious place for a beacon to see and be seen.
 I've contact Derby County Council and they are (subject to risk assessment and event details) minded to allow this.
 The Friends of Poulter Park are keen to assist in the creation of a celebratory event.
 I propose, subject to a detailed plan covering all permissions, event logistics and safety, that Langwith Parish Council fund the cost of a gas burner Queens Platinum Jubilee beacon and organise an event leading up to it being lit.

2. COUNCIL PAPERS GOING GREEN(ER)

In line with Bolsover's and National Plans and Policies to go-green, I'd like to propose that all Councillors be given the option to receive Council Papers by email (not only saving print and paper, but the cost of hand delivering them around the Parish).

In addition, I'd like to propose that Council Papers to anyone not wishing to receive them via email be printed double-sided (I recall that when we agreed to taking on Shirebrook's 'old' photocopier that one of its features was that it printed double-sided).

3. OVER-HANGING WILLOW TREES

I'd like to propose that action be taken to clear the road and pavement along the river running from the bottom of Pit Hill towards Nether Langwith of over hanging willow branches.

The trees themselves are on the far bank, on land which I believe is owned by Langwith House, but growth is now such that both the pavement and part of the road is becoming obstructed.
