The Parish Clerk gave an update on the current vacancy for the Administration Assistant post, it was agreed to review comparative salaries for all staff prior to advertising the vacancy again.

#### a. TO REVIEW PRECEPT DOCUMENTATION AND APPROVE PRECEPT FOR 2022/2023

The budget information had been provided with the agenda and Elected Members had had the opportunity to review it thoroughly prior to the meeting.

It was recognised that the effects of Covid had again negatively impacted on the budget in respect of income across both venues.



It was noted that general rising costs across most suppliers, particularly across utilities at all sites, would impact the precept demand but that the Clerk would continue to seek best value for supplies and works wherever possible.

It was also included in the budget to return to a full program of events throughout the year, which cater for residents of all ages.

Other projects discussed for inclusion included improvement to the Christmas Lighting Scheme and the planting schemas as well as taking part in the Extreme Sports project.

The following recommendations were included in the report;

- 1. That the budget assumptions are accepted, and any non-material amendments be delegated to the Parish Clerk.
- 2. That the above be considered alongside this report to show an increase in the precept demand of £12,000
- 3. That a precept of £160,000.00 be set.

# RESOLVED: To accept the Parish Clerk's financial reports, approve recommendations 1-3 above and notify a precept demand of £160,000 to Bolsover District Council.
